Change is Hard. Sustaining Change is Harder

How often do youth make significant leaps forward, only to fall back into patterns that they had tried to move past? Why do some youth thrive and other youth struggle to maintain progress?

Learn about the Five Domains of Wellbeing, the Full Frame Initiative's framework for helping people and families facing multiple challenges make *and sustain* progress. Missouri Division of Youth Services (DYS) and the Full Frame Initiative have collaborated to customize the framework for Juvenile Justice youth.

In addition to learning about the Five Domains of Wellbeing and how the framework is being applied in DYS, participants will learn—through a combination of presentation, individual and small group work—1) what current research tells us is vital for youth development in the context of trauma and challenge; 2) how applying the Five Domains of Wellbeing helps address root causes of delinquent behavior; 3) how this holistic approach holds promise for helping youth and families truly change their trajectories, remaining law abiding, safe and productive members of their communities; and 4) how this framework can be applied by court personnel, law enforcement, community workers and others concerned with helping youth in JJ become productive, healthy, fulfilled adults.

Juvenile Law Update

In this seminar we will highlight the Indian Child Welfare Act of 1978 (ICWA), which over the past year has received a great deal of attention in the media, as well as in legal, and social work discussions. This interactive session will provide a basic refresher course on the standards of ICWA, and describe the implications of tribal sovereignty on child welfare practice with American Indian and Alaska Native families. Topics will include: when ICWA applies; how to provide notice to a tribe; best practices for working with tribal governments; what evidentiary standards are required, the definition of active efforts, and compliance with placement preferences. This session will also provide an update on the status of the law including major court actions over the past year and any pending legislation that will affect its implementation. There will be space for questions, dialogue, and case examples throughout this session.

In addition to covering ICWA there will be special presentations on immigration law as it pertains to juveniles - what can be done if the juvenile is not a U.S. citizen?; can we help them get legal status, and what about criminal activity?; can we still help non-citizens? Traditional case law and legislative update will be covered along with the public defender's perspective on representing youth.

Human Trafficking

This workshop will address various aspects of human trafficking as it pertains to children and youth in Missouri and in the United States. Topics will include defining terms, risk factors, means of trafficking including internet, identification, intervention, Missouri human trafficking laws, building a coordinated community and state-wide response, resources and service options for trafficked youth, the impact of trauma, and trauma-informed interviewing. Attendees will participate in small group and large group discussions about the current status of response to trafficking and commercial sexual exploitation of youth, tools the current state law can provide, and where we need to go from here.

Trauma Informed Care: The Good, The Bad, and The Ugly

This workshop will provide a grass roots look at the trauma issues facing youth and those in their support systems. The sessions will utilize multimedia presentations, interactive lecture, and facilitated small and large group exercises. Information will be provided through means of poetry, music, and video provided by children or targeted toward them to enhance each participants understanding of trauma among youth and how it affects every part of their being, including self-esteem, lack of desire to meet basic responsibilities, negative reactions to authority figures, struggles in school, the family unit, and community. You will explore what trauma is, types of trauma, what causes it, what can be done to heal it, and what part professionals play in the healing process as part of the youth support system. A self-help session will be provided to allow each individual to consider their own trauma, how it can affect their support performance, and learn strategies they can implement to keep themselves healthier. Participants will leave this seminar more comfortable in how to respond to traumatized children, with a renewed passion for their work, and compassion for the youth and families they encounter.

Drug Endangered Children

Participants will receive training on Core DEC Community Awareness which encourages collaborative partnerships between law enforcement, child protection, and other practitioners and agencies. This presentation will increase community awareness about the risks faced by drug endangered children (DEC) and highlight the opportunities we have to intervene on behalf of these children. In this workshop, attendees will also learn how to look for signs of illicit drug use. They will be given an overview of various drugs of abuse and associated drug paraphernalia so that they are better equipped to recognize children who may be in danger as a result of illicit drug use. Discipline specific evidence collection along with marijuana effects on children and the family will be covered. Finally, what is addiction and how it affects the brain along with why children and teens' brains are more vulnerable to substance disorders and what the components of effective prevention, treatment and recovery are.
