Biography of Officer Mark A. Hall Logan-Rogersville School Police Dept.



Officer Mark A. Hall is a 32 year veteran law enforcement officer. Officer Hall currently serves as the District School Police Resource Officer for the Logan-Rogersville R-8 School District, in Rogersville, Mo. Officer Hall has served in this capacity for the past 7 ½ years. Officer Hall provides law enforcement services for the entire Logan-Rogersville School District, which is comprised of approx. 2,200 students and 5 schools and a Central Office. Officer Hall's official title is: Director of Safety/Security for the Logan-Rogersville R-8 School District.

Officer Hall has an undergraduate degree in Criminal Justice Administration from the College of the Ozarks (Hard Work U) in Point Lookout, Mo. In his 32 year law enforcement career, Officer Hall has served a city police officer in 3 cities in Mo. and has served as a Deputy Sheriff in 4 counties in Mo. as well. Officer Hall also served as a Deputy Coroner for 3 years. Officer Hall is also a former member of the Missouri State Water Patrol.

From 1992 to August of 2007, Officer Hall served as a Detective in the Criminal Division of the Greene Co. Sheriff's Department in Springfield, Mo., which is the 3rd largest county in Mo. Officer Hall served 14 of those years investigating Child Abuse/Sexual Abuse cases and investigating Crimes Against Juveniles. Officer Hall served 2 years in the area Computer Crimes investigations, and was assigned to the United States Secret Service Task Fork. Officer Hall also served one year on the United States Marshal's Fugitive Task Force. Officer Hall was also a member of the Greene Co. Sheriff's Department S.W.A.T. team for several years, as well as serving as an instructor for the Mo. Sheriff's Training Academy.

Officer Hall is currently a Mo. State certified School Resource Officer having completed the Basic and Advanced SRO training programs. Officer Hall is a certified instructor in the A.L.I.C.E. active school shooter training program; is a certified instructor for Strategos, Inc. in the School Active Shooter training program; and a certified instructor for the "Police Interactions with Youth" course through the Mo. Juvenile Justice Association. Officer Hall is also a certified volunteer Hunter Education Instructor for the Mo. Department of Conservation.

Officer Hall has completed the Instructor Development Course and was certified as a "Generalist" instructor through P.O.S.T. Officer Hall wrote and teaches the following training courses: Search Warrants, Computer Safety, Safe Driving 101, Drugs, and Personal Safety.

In 2013, Officer Hall was placed in charge of the Logan-Rogersville schools, "Constitution Project" team. Officer led a team of students from his school and mentored/instructed/taught them Crime Scene Investigation. An 8 school, Mo.state wide, competition was held for the Constitution Project.
