## **Matt Bellace**

### **Motivational Speaker & Comedian**

Since 1995, Matt Bellace, Ph.D., has been a professional speaker and stand-up comedian. His programs encourage over a hundred thousand students and adults each year to pursue natural highs (e.g. laughter, meditation) and be resilient in the face of stress.

Dr. Bellace has a Ph.D. in clinical neuropsychology, which is the study of the brain and behavior. He worked at the National Institutes of Mental Health, and completed his internship at the traumatic brain and spinal cord units at The Mount Sinai Medical Center in New York City. His dissertation focused on the neurological underpinnings of emotional memory.

He's the author of the book, *A Better High*, a contributing author for the *National Geographic Kids* and was a recurring comedian on truTV's "World's Dumbest." For seven years, he performed stand-up comedy in clubs and colleges across the country, including appearances at *Gotham Comedy Club* in New York City and the *Just For Laughs Festival* in Montreal.

As an undergraduate at Bucknell University, Matt founded a student prevention organization named C.a.l.v.i.n. & H.o.b.b.e.s. Over 25 years later, it is the oldest student group on campus, providing substance-free events every weekend of the school year. In 1995, the trustees of Bucknell approved funding to refurbish a former fraternity house for the group to reside. *U.S. News and World Report* heralded the move, noting, "How times have changed." Bucknell President, William "Bro" Adams referred to the group as "revolutionary."

# *Introducing the 2021 Missouri Teacher of the Year Darrion Cockrell*

After playing college football at Millikin University in Illinois for two years, Cockrell injured his shoulder. He returned home and earned a Bachelor of Science in Education/Physical Education and a Bachelor of Interdisciplinary Studies from the University of Missouri - St. Louis.

Cockrell or "Mr. DC" as he likes to be called, teaches physical education to students in grades K-5 at Crestwood Elementary School in St. Louis, MO. He has nine years of teaching experience and has been at Crestwood since 2015.

Cockrell received a 2020 National Box Tops for Education Twilight Award, presented by Chance the Rapper. He also created the "Crest-Fit" training program, reaching thousands of people in his community through multiple platforms, where he continues to share fitness videos online that he records with his son. In his free time, Mr. DC enjoys spending time with family and friends, staying active, watching sports and supporting his students in their activities.

**Plenary 1:30—3pm:****A Better High: The Science Behind Laughing, Meditating, Reducing Stress and Managing Emotions**

You won't want to miss Dr. Matt Bellace, a clinical psychologist and stand-up comedian, delivering his humorous and interactive keynote. The presentation will focus on using natural highs and other healthy ways to reduce stress and manage emotions for you and your clients. The program will also discuss dealing with disappointment during the pandemic and how to use cognitive reframing and other techniques to be more resilient. Dr. Bellace's unique style of integrating science with funny stories and audience participation should make for a memory kick-off to the conference!

**Workshops 3:15—5pm:****Go Beyond the Keynote with Dr. Matt Bellace**

The beauty of having a keynote speaker with such a varied background is the opportunity to have in-depth discussions. In this workshop, the audience decides which topics they want to talk more about, including substance abuse prevention, adolescent brain development, meditation or public speaking. Regardless of the topic, it will be an interactive conversation, not a lecture. For example, the teenage brain is as fascinating as it is maddening, so come prepared with questions and stories. Perhaps you're interested in learning more about meditation. There are many types to experience from body scans to mindfulness meditation to Transcendental Meditation. Dr. Bellace is ready to lead exercises in all of them so you can see for yourself. Finally, how about practicing using humor and engaging stories to be a more effective speaker? This fun segment will involve members of the audience standing up and speak out on a topic they feel strongly about. Dr. Bellace will provide supportive suggestions for how to be an effective advocate.

**Dealing with the Judge**

This session will address the pitfalls which exist in the relationship between juvenile court personnel and juvenile judges. The presentation will explain the philosophical basis for the rule against ex parte communication and how to avoid inappropriate exchanges of information with the judge. The discussion will explore questions about the appropriateness of various interactions with judges in a variety of contexts and the importance of maintaining the independence of juvenile officers.

**Temporary Alternative Placement Agreement (TAPA)**

Temporary Alternative Placement Agreement was created through legislation passed in 2020. It mandates how the Children's Division handles diversions outside of the home due to safety concerns. Part of this legislation requires the Children's Division to notify the Juvenile Office any time a child is diverted to someone that is not a parent. This workshop will cover the requirements of the statute as well as the Children's Division's policies around TAPA. There will be opportunity to discuss how implementation of TAPA is going for circuits and to clarify any questions participants may have.

Then we will end the session with an interactive discussion around current needs and system challenges and how healthcare companies can play a role in improving the lives of youth in the juvenile justice program.

This presentation will focus on the assets, strengths, contributions and potential of our young people. The pre-teen and teenage years are times of great challenge in a world that doesn't provide clear, positive values. This presentation will provide a framework for better understanding the actions and attitudes of today's young people. Keith will also provide practical suggestions for what a community can do to positively influence the choices of youth so that the community can proudly say, "Look at what's right with our children."

**Workshops 10:15—Noon:****Prosecutorial Discretion and Implicit Bias: Truth or Consequence**

There is a growing body of research linking the domains of implicit bias to the daily discretionary decisions made prosecutors and PK-12 disciplinary school administrators. Although limited empirical evidence supports the assumption that implicit bias impacts the discretionary decisions made by such authorities when assigning consequences, anecdotal experiences confirm that implicit bias greatly impacts their decisions. This session is an informal overview of findings that support the power of implicit bias in discretionary decision-making of authorities. Informal discussion and data should aid participants in understanding how biases enhance the prison pipeline.

**Independent Assessor-Families First Update**

On February 9, 2018 landmark bipartisan Federal legislation, the Family First Prevention Services Act (FFPSA), was enacted into law. FFPSA includes historic reforms to help keep children safely with their families and avoid the traumatic experience of entering foster care, emphasizes the importance of children growing up in safe families, and helps ensure children are placed in the least restrictive, most family-like setting appropriate to their special needs when foster care is needed. Missouri will move to full implementation of FFPSA on October 1, 2021.

FFPSA provides states the opportunity to use Federal Title IV-E funding for specific trauma informed prevention services that help keep kids safely with their families. FFPSA requires an independent assessment by a qualified clinician to determine if placement in a family setting or in residential treatment is the most effective and appropriate option to meet the needs of youth in foster care. It ensures that youth in foster care whose needs cannot be met in a family setting receive quality trauma informed residential treatment services that are short term.

The theme for FFPSA in Missouri is Prevention, Placement and Systemic Partnership. Please join staff from the Missouri Children's Division in this workshop to gain a better understanding of this historic child-welfare legislation that impacts all child welfare stakeholders.

Guardians ad Litem represent the interests of children in juvenile, family and probate court matters in the State of Missouri. Children, although always a vulnerable population, have not always had their interests represented in court proceedings. This presentation will look at how the role of the Guardian ad Litem has evolved into the current practice configuration, and how that has shaped and influenced an understanding that children’s interests and opinions need to be given consideration in preparing, negotiating, settling and trying cases. This session will also discuss and examine ways in which Guardian ad Litem practices are still in flux and how our Guardian ad Litem practices might be improved going forward.

**Parking Options/Fees:** Guests of the hotel can park at our **Surface Parking Lot for \$7/Day**, our **Self-Parking Garage for SPECIAL CONTRACTED RATE OF \$13/Day** for unlimited in & out privileges, or our **Valet Park for \$25/Day** for unlimited in & out privileges. Guests will check into the Hotel prior to selecting their parking options.

**Incidental Hold on Credit Card:** Guests that provide their own credit card for Incidentals, will have an authorized hold of **\$50/day** on their credit card account. If no Incidental charges are made during time of stay, anticipate 3 – 5 days post check-out before authorization hold is released. Discourage use of debit cards, as release of funds may take longer.
