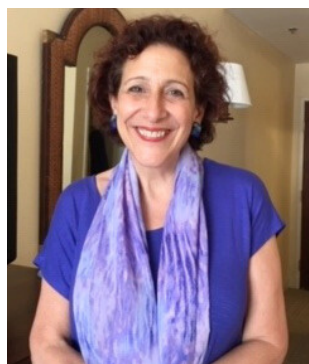


JOHNNY CROWDER

Wednesday Plenary & Workshops:

Plenary: Restorative Justice: Healing Trauma, Restoring Communities, and Reimagining Accountability—Lisa Daniels

In this impactful plenary session, Lisa D. Daniels, founder and executive director of the Darren B. Easterling Center for Restorative Practices, shares her deeply personal journey from tragedy to healing and how it led her to become a leading voice in restorative justice. Through storytelling and expert insights, this session will explore the profound impact of unresolved trauma on youth and communities, emphasizing its generational effects within the juvenile justice system.

Participants will gain a deeper understanding of how restorative justice provides a practical framework for fostering healing, accountability, and community restoration. Lisa will highlight the innovative programs developed by her Center and provide real-life examples of how restorative practices can break cycles of harm and empower both those who've caused harm and those who've been harmed. Attendees will be inspired to reimagine accountability and equipped with strategies to integrate trauma-informed, restorative approaches into their work.

Workshop: Understanding the Requirements of Youth Entering a Licensed Residential Care Facility; the Missouri Landscape

This workshop will provide an overview of residential care facilities licensed by the Department of Social Services (DSS), the Independent Assessment (IA) process, and the placement process by DSS. Ensuring that youth are placed in the right setting, with the right services, at the right time—in the least restrictive setting possible is the priority of locating appropriate placement.

Fentanyl: Who, What, Where, When and Why"?

Most people have heard of Fentanyl and many have heard misinformation circulating regarding Fentanyl. This misinformation can be very dangerous to various professionals including law enforcement, children and youth, as well as potential overdose victims themselves. The speaker will share the ins and outs of Fentanyl, it's history, it's appearance both in licit and illicit forms, debunk misconceptions, and provide examples from across the country. By having accurate information, people can feel safe when working in the field.

Rules of Eligibility for Student Athletes

The Missouri State High School Activities Association (MSHSAA) is a voluntary, unincorporated association of member schools. The schools have established a set of rules regarding the terms and conditions for the schools as members, and also the eligibility standards for students to participate in the interscholastic sports and activities. Among the standards are citizenship, which includes directives on eligibility after interaction with law enforcement. Due to the fact the majority of students in member schools are juveniles, juvenile officers are often in the middle of eligibility issues, even though they are not part of a member school. The rules and implications will be discussed in order to provide greater understanding.

Certification Procedure and Best Practices w/ Case Law Updates

This workshop will explain the juvenile court process of certification cases from start to finish, as well as provide a mock certification hearing to give attendees an inside look at the substance of certification hearings. More specifically, attendees will learn about the certification statute provided in Section 211.071, RSMo., applicable case law, the inception of certification cases upon a juvenile's presentation to detention, procedure as the case moves forward, the role of the deputy juvenile officer, defense attorney perspectives, and what all a certification hearing typically entails.

Social media is a permanent fixture in our world and there are a lot of bright spots to it – social media connects us, makes us laugh, introduces us to new ideas, and provides support. However, there are also negative and potentially dangerous effects related to substance use, mental health, online grooming, and human trafficking. This session will discuss emerging data related to the intersection of the four topics, as well as empower attendees to be a trusted adult in the lives youth by understanding the risk factors and learning ways to counteract them with protective factors.

This interactive workshop expands on the Wednesday plenary session, offering a deeper dive into the core principles and practices of restorative justice and their transformative potential for youth and communities. Led by Lisa D. Daniels, founder of the Darren B. Easterling Center for Restorative Practices, the session will explore how restorative justice shifts the focus from punishment to repair by addressing the root causes of harm and fostering accountability through healing.

Participants will engage in a restorative circle simulation and learn practical strategies for implementing restorative practices in their professional roles. The session will also address common barriers to implementation and provide actionable solutions for building institutional support. Attendees will be equipped with new insights and tools to create more compassionate, trauma-informed systems that promote healing and resilience.

This workshop is designed for juvenile justice stakeholders seeking to make meaningful shifts toward restorative approaches in their work.

Two out of every three children in the United States are impacted by a traumatic event. When children experience trauma or an extremely stressful situation, it's normal and natural for them to have a hard time coping afterwards. I'm passionate about teaching people how to support individuals impacted by trauma. I specialize in inspiring helpers so that they can support these children and be the hero in their life journey. During this training participants will:

1. Learn how many children are impacted by childhood trauma and how to identify them.
2. Learn how the brain and body respond to trauma and how that impacts behavior.
3. Leave with a 'Call to Action' and be equipped with many specific tools that are easy to use to support these children

Plenary: The Real Heros—Dave Pelzer

This rare heart-felt program is given by a man whose life was saved by a system that many ridicule as being useless and incompetent. This highly emotional presentation pays tribute to those who have dedicated their lives to making a difference in the life of a child, while at the same time educating the general public about the challenges faced by those in their chosen field. Dave carefully weaves the story of how his life was saved by teachers, a school nurse, the police department, social services, and the foster care system. This is the perfect keynote for those within the system who are in need of a positive shot in the arm from a man who, too, has dedicated his life to helping others.

Leaving Your Baggage Behind – Ensuring Fairness, Accountability, and Integrity through the Use of Object-Based Inquiry (Part Two)

This hands-on workshop, will, through the use of object-based inquiry activities, help participants create a space to discuss issues related to access to justice, diversity and inclusion, procedural fairness, and mitigation of bias in decision-making when working with youth and families served by the juvenile justice and child welfare systems.

Reducing Gang Violence through Law Enforcement and Community Partnerships

During this session, the presenter will first describe characteristics of gang members and different types of gangs. Next, different comprehensive models aimed at preventing gang membership and reducing gang crime will be presented. Lastly, the presenter will provide examples of implementing law enforcement-community partnerships and the vital role that the public's legitimacy of police in preventing or reducing gang violence.

Missing: Males in Our Response to Trafficking and Child Sexual Exploitation

Males are frequently overlooked in efforts to address trafficking and child sexual exploitation, leaving a critical gap in both prevention and intervention strategies. This course examines how adolescent males are impacted by domestic sex trafficking and the ways in which male children of all ages are targeted for sexual exploitation. From elementary school-aged boys being groomed on gaming platforms to adolescent males falling victim to sextortion schemes, this session sheds light on the unique vulnerabilities of this often-overlooked population. Additionally, the course will explore the heightened risks faced by LGBTQ+ youth, who are disproportionately affected by both trafficking and online exploitation.

Zero Tolerance Discipline Policies: The Gateway to Juvenile Justice Involvement and a Mother's Journey to Breaking Barriers

In this workshop I will share my personal testimony of navigating the challenges of raising a child with multiple disabilities and avoiding justice involvement through prayer, parent advocacy, and building strong connections. My journey as a parent advocate began with Missouri First Steps over 20 years ago, where my son and I had a wonderful experience. However, transitioning into public school brought significant challenges, including the fear that he would be funneled into the school-to-prison pipeline due to behavior issues. By the grace of God and the support of a strong network, I was able to advocate for Mikylin, who proudly graduated high school in 2022 with a STRONG FINISH! In this motivational talk I share the struggles and successes that my family experienced and our journey to purpose and healing.

Medical Mimics of Maltreatment

This session aims to educate juvenile court professionals on the medical conditions that can mimic signs of child maltreatment. By understanding these medical mimics, legal staff can make more informed decisions, ensuring interventions are appropriate and justified. By the end of this session, participants will have a deeper understanding of the medical conditions that can mimic child abuse and the importance of a careful, collaborative approach in these cases. This knowledge will help legal professionals make more informed decisions, ultimately protecting children and families more effectively.

Friday Plenary & Workshops:

Plenary: Trauma-informed Supports for people with Intellectual and Developmental Disabilities—Karyn Harvey

This session will explore the sources of trauma in the lives of people with intellectual and developmental disabilities and the effects of that trauma. It will then explore the key ingredients to healing and approaches that facilitate trauma-informed recovery and post-traumatic growth.

Positive Identity Development

This session will address the need for a positive sense of self and identity for youth with intellectual and developmental disabilities in order to heal from past traumas. Additionally, in this session the importance of identity and how identity development can be supported will be explored.

Listening Like an Anthropologist: Why deep listening matters for supporting transgender Missourians

This session is for those who work in the juvenile justice system who desire to increase their understanding of what it is like for those who identify as trans in Missouri (and the unique challenges they face). The majority of the session will be spent reflecting on video interview from our local trans community. If you have limited experience working with individuals who are trans, this session is specifically designed for you!

Preventing Low-Level Juvenile Offenses from Escalating into Higher-Level Adult Crime

Low-level offenses committed by young persons may escalate into future higher-level crime if the cause for the behavior is not addressed. A structured protocol should be developed by schools, juvenile courts, law enforcement and community-based service providers to identify the appropriate interventions to address the needs of the young offender and prevent future offenses. The presenter will discuss definitions of low-level offenses, MOU's and different types of interventions, to include accountability, skills development, mental health services and community connections. A specific example will be presented to describe in detail how to implement a school-justice partnership.

Confrontation Clause and Other Unique Hearsay Issues in Juvenile Law

This workshop will explore how the COVID-19 pandemic really challenged what we know about the Confrontation Clause of the Sixth Amendment and cases such as Crawford v. Washington. Attendees will also engage in a discussion of hearsay in juvenile law and any changes that have occurred to hearsay exceptions in juvenile law in the last five to ten years.

Juvenile Lifer Without Parole Speaks

Where did our juvenile justice system go wrong? How can we reach our most vulnerable youth? Bobby Bostic can help us answer those questions. Bobby was sent to prison at the age of 16 for a sentence of 241 years. Now, Bobby is a free man mentoring youth in local detention centers to help them make better decisions than he did. Come and have a candid conversation with a juvenile lifer without parole and ask all the questions you've never been able to ask.
